



# **Tons of Tournaments**

## **Over \$100,000 in cash and match play to be won**

1. Running from July 28- September 22, a total of 9, 2 table tournaments will play on to the final table on Friday September 29th- Autumn Moon Festival.

### **TOURNAMENT AND WEEKLY PRIZES**

2. Final table September 29th- 9 players (winner from each week).
3. Players drawn at random 8pm each Friday. Tournament begins 9pm.
4. Win ballots all week, every week to have a chance to be drawn to play.
5. Must be in attendance to qualify.
6. Weekly- 18 names drawn to play 2 table tournaments simultaneously. Top 3-win cash and prizes. Winner advances to final table.
7. Names drawn from ballot drum (non-smoking HL room).
8. Weekly draws at 10pm. 10 draws of \$500 match play. Draws are made from same drum used for ballots to get tournament entries weekly.
9. Final draws on September 29th will be taken from drum ballots collected the final week.

### **HOW TO WIN BALLOTS**

10. Every customer receives one free ballot by giving their players card or name and email or phone number (can receive the ballot any day of the week for that week starting Saturday July 22nd) Weeks run from Saturday to Friday.
11. Additional ballots can be won by winner 7 over 6 (player or banker with wager). 1 ballot for every winning bet \$25-\$250, 5 ballots for every winning \$251 to \$1000, 10 ballots for every winning bet \$1001 or more.
12. Winning ballots on Blackjack given out the same based on winning suited 21 or better on lucky lucky.

### **TOURNAMENT RULES:**

13. Starting stack- 25k in chips (poker tournament chips to be used)
14. Betting limit \$100-\$10000 (player or banker in \$100 increments) \$100 - \$500 on panda and dragon. \$100 - \$2000 on tie.
15. Each table plays 10 hands plus final "secret ballot" hand (11 total). Top 9 chip totals play to one table.
16. Final table plays 10 plus one "secret ballot hand". Top 3 chip total win 1st, 2nd, 3rd. Cash prizes of: \$1888, \$888, \$388
17. Tournament final table- all players get paid (\$38,888 total give away)
18. Previous 1st place finishers are permitted to win more than one seat on the final table but are required to either a) submit a name of person playing other seat(s) or b) forfeit the spot and receive the lowest remaining prize.
